#### 1. Overview

Insife HALOPV 5.1 is a minor release enhancing the capabilities of HALOPV 5.0 and provides various new features to its users. It contains several updates and changes, as detailed in section 4, addresses some key identified bugs along with some limited new/ updated features.

## 2. Upgradability

HALOPV 5.1 can be upgraded from HALOPV 5.0, and it can also be deployed as a standalone full installation.



## 3. Compatibility

HALOPV 5.1 is compatible with the following systems:

- Browser Compatibility
   HALOPV requires a JavaScript enabled browser and supports the current and prior major release of Google Chrome, Mozilla Firefox, and Microsoft Edge. HALOPV leverages Oracle APEX framework and is compatible with browsers supported by it.
