#### 1. Overview

Insife "HALO" 4.0.2 is a minor release enhancing the capabilities of HALO 4.0 and 4.0.1. It contains a small number of updates as detailed in section 3 to support some key identified bugs and issues, along with some limited new/ updated features.

# 2. Upgradability

HALO 4.0.2 can be upgraded from any previous HALO release (on top of a HALO 4.0.1 upgrade). It can also be deployed as a standalone full installation.



## 3. Compatibility

HALO 4.0.2 is compatible with the following systems:

- Argus 8.2.1.1 and Argus 8.2.3 (Please contact us for compatibility with earlier/later versions)
- ARISg 7.2 (Please contact us for compatibility with earlier/ later versions)
- Browser Compatibility

HALO requires a JavaScript enabled browser and supports the current and prior major release of **Google Chrome**, **Mozilla Firefox**, and **Microsoft Edge**. HALO leverages Oracle APEX framework and is compatible with browsers supported by it.

OBS: Support of Microsoft Internet Explorer was no longer supported from HALO 4.0
